First Baby Born at Sunnybrook's New Women & Babies Facility Promotion Rules

SPONSOR

The sponsor of this promotion is Sunnybrook Health Sciences Centre Foundation (the "Sponsor").

ELIGIBILITY

To be eligible, you must be a resident of Ontario over the age of majority, and give birth to a baby (or babies) in Sunnybrook's new Women & Babies Facility – M5-2075 Bayview Avenue, Toronto, Ontario (scheduled to be in operation on or about September 12, 2010). Scheduled cesarean births are excluded from the promotion. THE PRIZE

WINNER DECLARATION

The mother of the first baby born (defined as: brought into life by birth) in Sunnybrook's new Women & Babies Facility – M5-2075 Bayview Avenue, Toronto, Ontario will, subject to eligibility and compliance with these rules, be awarded the Prize. The on-duty charge nurse will judge and declare the mother to be awarded the Prize (the "winning mother").

The winning mother will be notified in person. In order to be awarded the Prize, the winning mother must sign and return (so that it is received by the Sponsor within 5 days of the notification date) a Declaration of Compliance, Release and Publicity Consent, in the form provided by the Sponsor to the winning mother at the time of notification.

The decisions of the on-duty nurse and the Sponsor will be final and binding.

The Sponsor (including its affiliates and related entities), together with their respective agents, representatives, successors and assigns, and all of their respective employees, partners, directors and officers, (collectively, the "*Releasees*") shall not bear any liability for or in connection with (a) loss, theft, use or misuse of the Prize, (b) any property damage, personal injury, death, loss or misfortune in any way attributable to this promotion and/or the Prize or (c) any delay in the opening of the new Sunnybrook Women & Babies Facility.

The winning mother will be required to release the Releasees from and against any and all claims, liability and causes of action (including all costs and expenses related thereto) in any way relating to or arising in connection with the promotion and/or the Prize.
