

# GIFTS THAT KEEP ON GIVING

"We know the struggles of living with hearing loss. With this gift, we hope to make cochlear implants more accessible to others." For Jeff and Debbie Gifford, leaving a legacy gift to Sunnybrook in their Wills was a fitting way to say thank you for the high-quality care they experienced when they both received their second cochlear implants a few days apart during the second wave of the pandemic. The implants changed their lives so greatly that Debbie believes they got "a second chance at life."

#### **Innovative devices**

Until receiving her first cochlear implant in 2016, it had been close to 35 years since Debbie was able to pick up the phone and call her mom.

While the 61-year-old had been born able to hear, a series of severe ear infections when she was young had caused profound hearing loss. Debbie's mom had supported her every step of the way as she began navigating the world with an invisible disability. But routine tasks like talking on the phone could be unbearable.

Poor sound quality and lack of visual information make phone calls challenging for people with hearing loss. When Debbie's mom moved into a retirement home, communication became even more difficult.

Her voice thick with emotion, Debbie remembers after her first procedure when she heard her mom's voice on the telephone: "It was like we didn't miss a beat."

#### Improving accessibility to care

Wanting the same life-enhancing moments for more patients inspired Debbie and her husband, Jeff, to support Sunnybrook's cochlear implant program with a legacy gift. Jeff was born with some hearing loss – it ran in the family – that declined throughout his childhood. After he saw how much the single cochlear implant had helped his wife, he went in for his own surgery in 2018.

"Sunnybrook has become our home away from home, everyone has been so kind," says Jeff. "We know the struggles of living with hearing loss. With this gift, we hope to make cochlear implants more accessible to others."

Sunnybrook, which has the largest cochlear implant program in Canada and one of the largest in North America, is leading the way with this emerging, exciting approach. Rather than amplifying sound like a hearing aid, which are helpful for some people with residual hearing ability, a cochlear implant provides the sense of sound by stimulating the auditory nerve directly. Sunnybrook otolaryngologist Dr. Vincent Lin is helping to pioneer the procedure.

Since receiving their second cochlear implants, the world has opened up to Jeff and Debbie like never before. "We feel so lucky to have implants in both ears, our quality of life is so much greater than we ever expected," says Debbie. "We're committed to supporting this program at Sunnybrook now more than ever."

Today, the retired couple is busy renovating their home, and is excited to finally make travel plans. "I was always reluctant to travel, I felt like I'd rather be in my safe space," says Jeff. "Now I can't wait to try new things!"

But it's the everyday moments Debbie remembers most, like the first time she could tell the difference between bird songs and of course, chatting with her mom. Jeff still remembers how important that first phone call was for his wife. "It was just so exciting for both of them. Her mom never thought that her

daughter would be able to communicate with her in that way," he says, before adding softly: "It still gives me goose bumps."

### **MURIEL DOBBIE - MAKING A DIFFERENCE**

Muriel Dobbie was a private person. She was also an extremely generous one. After her passing in 2020, Sunnybrook was grateful to learn that she had remembered the hospital with a generous gift in her Will, specifically for St. John's Rehab.

When Dr. Larry Robinson, Chief, St. John's Rehab, first heard of the gift, he thought: "How wonderful is this?" as estate gifts like Ms. Dobbie's enable the renowned St. John's Rehab Research Program to attract and retain some of the most highly qualified scientists and investigators in the rehabilitation field. Dr. Robinson shares "It is only because of donors, like Ms. Dobbie, that we can make this level of impact in the lives of our patients and in our communities."

Over its 75 years, St. John's Rehab has become a national leader in specialized rehabilitative treatment. But the rehabilitation offered today differs vastly from that provided in its earliest years. Why? Extensive and evolving research, along with the implementation of its findings, has transformed patient care.

A good example is the work undertaken around the impact and needs generated by COVID-19. As one of three facilities in the greater Toronto area offering inpatient rehabilitation services to COVID cases, the needs of both patients and staff soon became clear to research scientists at St. John's. How could Sunnybrook provide the best possible care for COVID patients? What specialized services were needed? How could medical practitioners provide optimal care while concurrently keeping everyone safe? How could St. John's specifically maximize patient recovery?

George Karkanis tested positive for COVID-19 at the end of the 2020, and while dealing with cognitive and physical symptoms associated with Long COVID, George worked virtually with clinicians at St. John's Rehab to build his mental and physical strength.

George explains: "There's not a lot of information about long COVID right now, and at times, it felt like I was alone or that it was never ending. My care team was really supportive of my journey and if I stumbled or needed help, they were only an e-mail away."

More recently, research has focused on best practices in the care of those dealing with Long COVID.

Specifically, St. John's Rehab scientist Marina Wasilewski, PhD, led one of the first studies in Canada to explore the entire COVID-19 patient care journey – from acute care, to rehabilitation, to returning back into the community. Her extensive qualitative research determined three critical findings: the need for compassion, the need to balance critical care with human connection, and the need to reduce fragmentation in COVID care across the system. These findings are now being implemented and serve as the cornerstone for recommendations to improve the COVID-19 care journey at Sunnybrook and beyond.

With thanks to donor support, last year St. John's was able to provide effective, quality care to over 60 in-patients with COVID-19, ranging in age from 20 to 90 with an average stay of 18 days. In addition 40 outpatients with Long COVID symptoms have already benefited from St. John's services. Donor gifts have also enabled the renovation of patient facilities at St. John's to ensure maximum safety from COVID-19.

Sunnybrook strives to maximize the benefits of each legacy gift they receive. Sander Hitzig, PhD, research director of St. John's Rehab research program, shares: "Dr. Wasilewski and her work exemplify the high calibre of scientists we have here at St. John's. Research has helped solve problems as they emerge, which has enabled better patient care. St. John's can also use its research findings as a platform to generate additional funding. It's a win-win."

### A WORD ABOUT EXECUTORS

Your executor (or estate trustee) ensures your assets are distributed as you wish.

You need a methodical, trustworthy person who is willing to take on the task and who appreciates what is important to you. If your estate is simple, you might choose a family member, with an alternate named should your chosen executor be unable to serve. A more complicated estate might require several executors, each responsible for a specific part of the estate.

Because of the complexities of estates today, it might also be wise to consider a corporate trustee such as a bank, trust company, or legal firm to act on your behalf. Executors can charge for their services, if they wish, but all are expected to make business decisions in the best interests of your estate.

Finally, it's to your advantage to arrange your Will and other personal papers so that your executor can easily find them, clearly ascertain your assets and debts, and notify your beneficiaries.

Consider if you would like to leave a specific amount of money or a percentage of your overall estate. Your professional advisors can help determine what is best for you.


## PLANS, FUNDS AND GIFTS TO SUNNYBROOK

RRSPs or RRIFs can be used to create a gift for Sunnybrook and the financial savings for your estate could be significant. Here's why:

When a person passes away, the total value of the funds in their registered retirement account must be reported as income. This income is fully taxable to their estate unless funds in the registered account can be rolled over to a surviving spouse or a dependent child. However, if a charity like Sunnybrook Foundation is made beneficiary, the gift remains outside the estate, thereby reducing probate fees while creating a gift that will provide a tax receipt for the estate. This receipt can be used to offset other taxes that may be incurred. It's a winwin.

Speak to your financial advisor to see if gifts of RRSPs and RRIFs are right for you. We are always here to act as a resource for you as well.
