JUNE REPORT

3.1 PATIENT STORY

Dr. Smith commented that he had previously presented highlights of the first Canadian patient to receive a procedure called, 'deep brain stimulation' for post traumatic stress disorder. Prior to the procedure, the patient suffered so badly from PTSD that she was unable to leave her house most days and lived in fear of loud noises. In follow-up, Dr. Smith reported that following treatment, her recovery has been remarkable. The patient is now able to leave her house, drive, run errands and is able to live a much more normal life.

5.0 **EDUCATIONAL PRESENTATION:**

Dr. Smith welcomed and introduced Dr. Ben Goldstein, Director, Centre for Youth Bipolar Disorder, Vanessa Timmins, Social Worker & Research Coordinator and Dr. Brad MacIntosh, Senior Scientist, Medical Biophysics. A copy of their slide presentation, entitled 'Integrating Brain and Body in the Research and Treatment of Youth Bipolar Disorder' was pre-circulated and appended to the agenda portfolio. Dr. Smith also welcomed Dr. Anthony Levitt who was on hand to answer any questions.

Dr. Goldstein provided a brief overview and background on the Centre for Youth Bipolar Disorder (CYBD). The Centre was established in August 2009, entirely donor funded, as a subspecialty clinic and research program focused on adolescent bipolar disorder. Starting with a staff of 2, has grown to a team of 20+ including psychiatrists, social workers, psychiatric residents, graduate students and research staff. It has become a 'one stop shop'. Its mission is to improve outcomes for teenagers with bipolar disorder through cutting-edge research, treatment, education and advocacy.

Ms. Timmins highlighted and presented an overview of what the clinic does, noting that the CYBD takes its accountability to the patients seriously and to this end they focus on:

Rapid referral, with a target wait time of approximately 2 weeks.

- Comprehensive evaluation: each patient receives a 5-hour assessment, regardless of their choice to participate in research.
- A specific focus on bipolar disorder in addition to an integrated approach to physical and mental health.
- The Centre provides access to gold-standard psychosocial treatment without wait time and cost.

Ms. Timmins commented that CYBD receives referrals from a large breadth of institutions across Ontario. Patients come from as far as Timmins to the north, Ottawa to the east and Windsor to the west. More than half of their patients are referred from other psychiatrists. In terms of region, CYBD does not use a catchment area and will accept referrals from anywhere within Ontario with the vast majority of patients coming from outside of Sunnybrook's catchment area and about 1/3 from outside the GTA. Ms. Timmins commented that the Centre is truly a provincial resource and is part of Team Ontario as a leader in adolescent bipolar disorder treatment.

Exercise as Medicine for Adolescents with Bipolar Disorder (Team-BD). Youth with bipolar disorder generally exercise less than other youth. The Centre recently received a major grant from Brain Canada Foundation to design the first exercise intervention study focusing on improving aerobic fitness among people with bipolar disorder. Dr. MacIntosh presented an overview of the study and highlighted MRI Assessments before and after exercise. He commented that exercise sessions help to restore cerebral blood flow in bipolar disorder.

The Chair thanked all for a most informative presentation and opened the floor for questions.
